1._By purchasing a ticket or season ticket, by receiving other proof of entry or by applying for entry to the sporting event, the participant accepts the rules of the sporting event

- 2._A participant may be admitted to and remain at the venue of a sporting event if:
 __2.1. has a valid ticket, pass or other proof of access (e.g., invitation, accreditation, with a card issued by MKOSZ, etc.) for the sector reserved for them;
 __2.2. approaches his/her seat, sector and place of work on the route designated to him/her and stays there in accordance with the instructions laid down in advance;
 __2.3._occupies only the space indicated on his/her ticket/rental/invite/accreditation and uses only the facilities and service units specified for him/her;

2.4. undertakes to:

- 2.4.1. provide proof of identity when requested to do so by the person responsible for ticket sales of the organiser or the organiser:

 2.4.5. does not litter and respects the rules on smoking;

 2.4.7. carry out commercial activities only with the prior written consent of the organiser,
 2.4.7. carry out commercial activities only with the prior written consent of the organiser or on the basis of a contract, including in particular information transmitted to sports betting operators and on-line sports betting data providers and their subcontractors, as well as recordings concerning the event's property rights.

 4.12. an object that is difficult to handle, cannot fit under a chair, endangers the conduct of the sporting event, endangers the safety of others, disturbs the players or officials, or interferes with the enjoyment of other spectators;
 4.13. apulpment that could be used for an act of violence or the possession of which is prohibited by law or the organiser of the sports event;
 4.14. signs, flags or clothing that incitle hatered towards others, have political content or offend others;
 4.15. an object whose interpretation is not clear, or whose interpretation has not been presented to the organiser in advance;
 4.15. wears an authoritarian symbol or clothing prohibited by law, or has a tattoo with this content;
 4.17. pyrotechnic articles, articles capable of being used in a flammable activity, the possession of which is contrary to fire safety rules;
 4.18. alsers or other similar beacons harmful to health and transmission, or noise-making devices prohibited by the organiser;

- 4.1.9. an object for promotional or commercial purposes:
- 4.1.10. video camera or professional camera:
- 4.1.11_a pet, except for a disabled spectator, an assistance dog.

 4.2_undertakes to:

- 4.2. undertakes to:
 4.2.1. does not climb or stay on the fences or other objects of the establishment;
 4.2.2. display and wear only the official national flags of the competing teams and the official club flags and emblems of the competing club teams;
 4.2.3. flags display only the names of the official clies of the country;
 4.2.4. to send in advance to the organiser, or to agree to the prior control of the organiser and the organiser's intermediary, the introduction of flags, banners and supporters' symbols larger than 2x1 m;
 4.2.5. displaying the choreography only with the permission of the organiser;
 4.2.6. be in the sector or seat indicated on his/her ticket, pass or other proof of admission;

- __4.2.7._does not throw any object onto the playing field, into an area out of the spectators' reach or onto persons in the vicinity

- 4.2.7. Joses not throw any opject onto the playing field, into an area out of the speciators reach or onto persons in the vicinity;
 4.2.8. does not enter the playing field or areas closed to speciators without permission and does not attempt to engage in such behaviour;
 4.2.9. does not disturb any national, official or competition-related anthems;
 4.2.10. does not stop on an escape routle (e.g. or, the steps of a sports facility), but leaves escape routes, corridors, entrances and emergency exits clear;
 4.2.11. does not engage in racist, hateful, offensive, ideological, religious or political conduct, or display or engage in any signage or conduct with such content;
 4.2.11. does not disturb the view of others by its cheering and behaviour;
 4.2.13. does not clisturb the view of others by its cheering and behaviour;
 4.2.14. does not cover his or her face, except for public health reasons, to ensure that his or her identity is always guaranteed.

 5. The organiser or the organiser if a director is used and the representative of the travelling sports organisation are entitled to observe and record the participants during the sporting event with a camera of a quality that allows the individual identification of the participants, in order to ensure the safety of the participants and their property. The data processed using the camera systems will be stored for a period of 3 days if necessary to initiate or conduct any exclusion or other official procedure. If no such request is received, the recordings will be destroyed after 72 hours. Camera recordings will be handled in the manner detailed in the data management notice.

 6. Any person who resists by force or threat a lawful action taken by a police officier or a director to maintain order, enters or attempts to enter an area which is closed to spectators or a specific group of spectators, or throws into such an area an object which endangers the holding of the sports event or the physical integrity of others, commits a crime.

 7. The organiser shall order the participant who endangers the holding of the sporting event or the persons authorised by the organiser.

 8. If a participant or person applying for entry fails to comply with the conditions set out in the rules of the event or engages in misconduct during the event and does not stop when warned by the organiser, helshe shall be refused entry to removed from the event.

- The director shall also have the right to detain the person detained if this is necessary for the preparation and communication of the exclusion decision to be imposed on the person detained.

 10_Anyone who has been removed from a sporting event or who has not been removed because the organiser (director)'s intervention at the venue of the sporting event was likely to result in spectator action that would have disproportionately endangered the safety of the sporting event, will be excluded.

 11_The organiser shall ensure the documented receipt of objects that cannot be taken in under the rules of the course, provided that their possession does not contravene the law, their safe keeping and their return to the rightful claimant upon departure. Food, drinks and medication may not be taken in los safekeeping. If the owner fails to report within 7 days of the end of the sports event, the organiser or the organiser shall not be obliged to ensure the continued safekeeping of the object and the owner or any other person shall have no further claim, whether pecuniary or non-pecuniary, against the organiser or the organiser.

 12_The organiser has taken out liability insurance for persons holding tickets, season tickets or invitations and other proof of entry for matches covered by the Government Decree on the security of sporting events, and the existence of such insurance is indicated on tickets and season tickets for sporting events.

 13. If an access control system is used, the organizer may make the presentation of personal identification cards (pensioner card, student card) with photos and entitlement to discounts mandatory. In the absence of presenting discount cards, discounted tickets and assass cannot be used for entry, meaning entry to the venue of the sporting event may be denied.
